# LLM Program

Master of Laws in American Law

International students can immerse themselves in the U.S. legal system and strengthen their career prospects with a Master of Laws in American Law (LLM). Designed for lawyers or barristers with law degrees from outside the U.S., the LLM program at New England Law | Boston provides the skills and credentials necessary for taking the bar exam and working in the United States.

### Scholarships

New England Law's merit scholarships are open to LLM students, and all applicants are automatically considered for these generous awards. There is no separate scholarship application.

### Location

Ideally located in downtown Boston, New England Law is a short walk to the city's top attractions and legal institutions, including the State House, Massachusetts Supreme Judicial Court, Financial District, and many prestigious law firms.

Given our central location and proximity to public transportation, off-campus housing is also easy to find.



One-on-one attention from a dedicated faculty advisor and a wide-reaching alumni network ensure academic success and global connections.

### Faculty

New England Law's accessible faculty help LLM students make a seamless transition to the U.S. Their expertise spans the breadth of legal discourse, and they have held such positions as Chief Justice of the MA Superior Court and Director General of the Human Rights Department for the Organizations for Security and Cooperation in Europe.

### Alumni

New England Law's alumni live and work in 31 countries and all 50 U.S. states. They work in virtually every legal specialty and have held positions such as Massachusetts Lieutenant Governor, Desk Officer with the U.S. Department of State, and Senior Vice President Basketball Operations for the Indiana Pacers NBA team.

From a comprehensive orientation to postgraduate advising, international students get the support they need to succeed.

### A Strong Foundation

The LLM program begins with an orientation to the law school to help students adjust to living and learning in the U.S. LLM students can also enroll in our Responsible Lawyering course for first-year JD students; this course focuses on legal analysis skills and provides students feedback on practice U.S. law school exams.

### Curriculum and Legal Specialties

LLM students can choose from more than 100 courses, including Constitutional Law, Criminal Law, and Ethics of Lawyering. LLM students can also specialize in many legal areas, including:

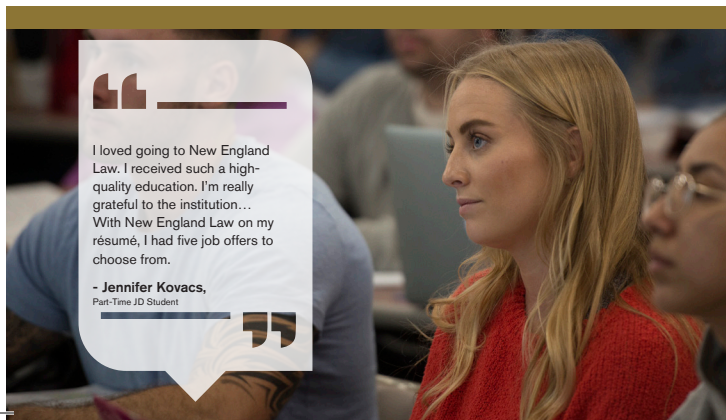
