Stetson University College of Law's LL.M. in International Law allows students to excel their legal education in an **intensive one-year program that leads to an advanced legal degree in international law.** This program is ideal for domestic and foreign-trained lawyers seeking to enhance their career in business, government, education, or the law on a global scale.

Stetson's program accommodates the specialization needs of both experienced practicing attorneys and recent law school graduates from the U.S. and abroad.

EXPERIENTIAL OPPORTUNITIES

Students complete 4 credits of experiential or simulation classes as part of their degree. Students have the option to substitute a clinic or field placement with approval of the Director of Clinics and Experiential Education and the Associate Dean of Academic Affairs. These programs are designed to enhance classroom-based learning and give students opportunities to gain valuable, real-world experience while working closely with Stetson faculty. Stetson Law offers more than 300 clinic or externship opportunities each year.




